- c. For holders of securities account in KSEI Collective Custody shall provide the List of Shareholders who manages to KSEI to get a written confirmation for the Meeting ("**KTUR**").

Proposal from the Company's Shareholders can be included into the official Agenda of the Meeting, if it satisfies the requirements as stated in the Article 11 point 16 of the Company's Articles of Association, and should be received by the Company's Board of Directors at the latest 7 (seven) calendar days before October 13, 2016.
